Situation

Ed Switalski, the Fire Chief in Comstock Township, Michigan, responded to a minor freeway accident where the driver had abandoned the vehicle. At that moment, a passing motorist lost control of his car while traveling more than ninety miles per hour. The motorist struck the Chief with the car, and the Chief was pronounced dead at the scene.
